Re: Telepathic Evidence

Brother Travis put a period in the subject of the the email on August 5th, 2026 posted to right. The subject line says “Received.” with the distinct period in place.

Furthermore he fails to mention anything at all among the abundant requests that were made in all the letters that were sent out to the Inland Vineyard Church. Sam, who is in leadership with no title and salary, the last time I checked, is the only person who responded to any letters or communication due to Sam being a longtime “friend” of Michael’s, something that Travis has stated of himself with no semblance of proof.

The amount of evidence in the chain of emails is large and worth review. The word of wisdom *A Pastor must have some semblance*, was delivered to Michael on account of exactly this type of communicate and style of response from Travis Twyman, who in all respects is a five-fold Teacher.

The period at the end in the subject line is evidence of telepathic bondage. He resorts to a noteworthy reply that obviously does not make any distinctive communication as to the result of leadership, his, or his wife Angie’s decisions, their thinking, the result of their requests to Holy Ghost, and what will transpire now that he has stated the messages are received. Is it determined that the fellowship as a whole will not answer any request or reply to any message, including Michael’s friend Sam on the phone who had begun not to return all forms of communication? Is leadership and the ecclesia told by senior executives not to answer Michael and ignore his requests? Or has there been a determination that Michael is not in the correct state of mind, and that he is in agreement with heathen spirits?

The result is bewilderment and a type of bearing potion that is cast to Michael, and anyone treated in such matter, due to the nature of the request, official correspondences, and distinct and specific direction that the ecclesia is taking, determined to take, or if they are still deciding on the matter as a whole, even still, if Travis as the senior member of the ecclesia at the Inland Vineyard is not allowing the leadership to reply at all. This is telepathic in placing the period as a

statement, unless it was a typo or accidental. It leads the recipient to not understand exactly the message that is being delivered but requires the recipient to contemplate to ascertain the nature, motive, and intention of the sender.

How could this be a Pastor doing this? *A Pastor must have some semblance* of sitting in the office of God's official government as Pastor and fulfillment of the roles that he or she is given for the sake of honoring the office and title of Pastor, as well as earning the income from the extensive salary package senior pastors make at a church the size of the Inland Vineyard Church, who holds extremely large cash reserves. This is a further testament to the obvious bewilderment as to why no other leaders such as Samuel Rubio and Kelvin(?) have not been promoted to the title and office of Pastor, attesting to the nepotistic nature of the Inland Vineyard as a whole.

If I were related to the family in any capacity, had spent years ingratiating myself with Travis through unquestioning deference, or were less knowledgeable about the Gospel than I am, trust me—Travis would have acknowledged me and taken the time to minister to me. That's because he loves to teach, not listen to pertinent requests that challenge the knowledge he professes and causes him to elevate to a higher degree of elevation in the spiritual nature of the Kingdom in Heaven. Even still after much time had been spent allowing Travis even more ample opportunity to address the complaint officiated by Michael, yet transcribed and originating directly from God's spirit wisdom, the wisdom became and I quote "*furious*". While I was a member at the Inland Vineyard Church I submitted to Travis as the evidence shows [please watch the youtube video titled **The Purpose of Spiritual Gifts**].

Travis did not take the time to teach me or shepherd me better yet even, to use my spiritual giftings. He did not uphold the virtues he is teaching. There is more. There is the video in which he speaks of not dishonoring an astute, beautiful disciple who is extremely attractive and gifted, by covering their light; Yet Travis refused Michael's request to 'help him climb the steeple', even after he was shown the video of the anointing given by global sitting Prophet & Apostle Tomi Arayomi. The bible is the roadmap, and, when there are matters in which it is not obvious to ascertain the direction or choice to take, then non-legalism is worthy of practice. However, when it is obvious that a biblical New Testament explicit directive is the way, then it becomes more obvious to all in being the correct path to follow.

The period in the subject line is evidence as to the nature of Travis' telepathic tendencies. How hard would it be to answer a direct question? He personally doesn't care to. This has been his style from day 1, even upon our first personal and physical meeting when a gracious and grateful member of the Inland Vineyard Church led me up to Travis to introduce me to him, at the ending of the first service I ever attended. I was excited, and he was immediately and deliberately stand-offish, in a dismissive way. I left not understanding what was the path ahead. He fed me merely to the point of only through Sunday sermon. That's it. He always would try to promote his personal ministerial podcast with his buddy who is not elevated to a pastor [Kelvin (?)], but a group leader he allows to preach on Sunday mornings to fill in. Yet he never takes the time to perform one on one ministry to me, others I have heard of, as part of his official duty, unless you're one of his buddies. This is outside looking in. It's for the Ecclesia to decide after consulting with Holy Ghost.

Raise the Assembly. Holy Spirit will judge. Not Michael, not Travis, now any other member but the true head. Jesus Christ the man.
